Ancestor Solomon Smith came to Oregon in 1832, married the Clatsops Chief Goboway's daughter Celeste. He was the first school teacher in Oregon. Solomon was one of the men at the May 2, 1843 meeting at Champoege who vote making Oregon a state. He was elected to be the first Senator for Clatsop and Tillamook Counties. He was remembered as a teacher, pioneer, missionary, millwright, farmer, merchant, state senator, truly a generous and public-spirited citizen.

EDUCATION

High School Graduate, 10 1/2 years with the United States Department of Agriculture Soil Conservation Service. I worked with the Plant Nursery Division out of Bellingham, Washington. We did research and plant selection with thousands of species from all over the world for use in erosion control work on a wide variety of problems including forestry land management. While stationed at the Florence, Oregon office I was assigned to the dune stabilization project in the winter season and during the summer working on soil survey and developing farm plans in the Lower Siuslaw River Watershed. Those plans included management options to reduce erosion from farm forestry lands.

MILITARY SERVICE

Joined the US Marine Corps in 1944. Was assigned to the 1st Marine Division where I served as a telephone lineman on a Forward Observer Team. Wounded by a machine gun fire on May 10, 1945. Okinawa campaign during a battle called Death Valley. Then 8 months in 7 hospitals before honorable discharged.

EXPERIENCE

In 1953 I formed my own dune stabilization business. Contracted large and small dune stabilization jobs for 41 years. Conducted two national research sites for the US Army Corps of Engineers Environmental Section out of Vicksburg Mississippi, both contracts were three year projects on the Columbia River in Oregon. Millers Sand Island on the lower Columbia River, first time research on intertidal zone of 5' above MLW to .5' below MLW. Complete success. Second site at Wallula Reservoir behind Mc Nary Dam on upper Columbia River. Search for and identify 15 vascular species and 10 woody species that would restore habitat vegetation to the daily 5' fluctuating draw-down area. Three year effort also highly successful site (only three nationwide). Research led to teaching at US Agency personnel workshops in Georgia and Mississippi. Teaching on marsh creation and restoration techniques.

Many years of involvement in local and state government as the Mayor of Florence, Oregon, Port Commissioner at the Port of Siuslaw, the elected Chairman of the Oregon Conservation and Development Commission (OCDC) in the 1970's, a Boardmember of the Lane Council of Governments (L-COG) and the Oregon Coastal Zone Management Association (OCZMA), this has given me invaluable insight into local and state government. With my knowledge of plants and experience in government it has helped me be an effective negotiator with various state and federal resource agencies.
